SENIOR CHIEF QUARTERMASTER (SURFACE WARFARE/AVIATION WARFARE) SHERMAN HAYLOCK OPERATIONS DEPARTMENT LEADING CHIEF PETTY OFFICER, USS MONTGOMERY (LCS 8)

A native of Los Angeles, Senior Chief Quartermaster Sherman Rodney Haylock enlisted in the United States Navy June 2000 at Navy Recruiting Station Tacoma, Washington, followed by reporting to Basic Training at Recruit Training Command, Great Lakes, and Illinois on September 18, 2000. Following graduation from basic training, he attended Quartermaster "A" School at Naval Training Command, Great Lakes, Illinois.



His first assignment was aboard USS Carl Vinson (CVN-70) home ported in Bremerton, Washington from February 2001 to June 2006 ending in a Homeport Shift to Norfolk, Virginia for Refueling and Complex Overhaul (RCOH). During his tour, he deployed three times. The first deployment was to the Arabian Gulf and North Arabian Sea in support of Operation Southern Watch and Operation Iraqi Freedom. The second deployment was to Seventh Fleet AOR in support of Exercise FOAL Eagle, Tandem Thrust and ULCHI Focus Lens. The third deployment was a world cruise, operating in Third, Fifth, Sixth and Seventh Fleets in support of the Global War on Terrorism. During his tour, he earned the Enlisted Surface Warfare Specialist and Enlisted Aviation Warfare Specialist qualifications and two Navy and Marine Corp Achievement Medals. He received promotions from Seaman Recruit to First Class Petty Officer. He was awarded the Navy Battle E, Navigation White Wheel, Navy Unit Commendation, Meritorious Unit Commendation, and Global War on Terrorism Expeditionary Medal and Global War on Terrorism Service Medal.

In July 2006, he reported to Navy Recruiting District Los Angeles. He recruited out of Norwalk Recruiting Station and was Southern Zone Delayed Entry Program Coordinator for Navy SEAL, EOD, SWCC and SAR Swimmer applicants ensuring they attained and maintained their aptitude proficiency prior to Basic Training. During his tour, he earned the Navy and Marine Corp Achievement Medal and the Navy Recruiting Service Ribbon. He transferred in October 2009.

He served aboard USS Pearl Harbor (LSD 52), home ported in San Diego, from November 2009 to September 2012. During this tour he deployed twice; first deploying to Fifth Fleet and Seventh Fleet AORs in support of Operation Enduring Freedom, Timor Leste and Sri Lanka Theater Security Cooperation, EAGER MACE, Pakistan Humanitarian Disaster Relief (HADR) and conducted Counter Piracy Operations rescuing and aiding 60 Somali refugees. The second deployment was in the Fifth Fleet AOR in support of Operation Enduring Freedom and Leaders

to Sea. During his tour, he was ranked #1 of 27 FCPO's earning the SSOQ, SOY, and promoted to Chief Petty Officer.

He transferred to USS Dewey (DDG 105), homeported in San Diego, from September 2012 to November 2014. During this time the ship movements were limited due to Sequestration. He deployed at the end of his tour for 3 months navigating the ship safely to Fifth Fleet.

In January 2015, he reported to Afloat Training Group San Diego, California. He trained more than 20 warships to include CVNs, CG's, DDG's, LHA's, LHD's, LSD's, MCM's and Coast Guard Cutters. He revised CE and RE Gradesheets for the Fleet and provided substantive input for the NAVDORM, Bowditch, Redlines, SFRM, SFEM, SFTRM, AIRFOR TRAMAN and local command instructions. He also wrote the Quartermasters Advancement Examination in Pensacola, Florida. He transferred to LCS training pipeline in June 2018.

He currently serves aboard USS Montgomery (LCS 8) (Blue) Crew 208.
